1. Review and discuss opportunities for improvement at each stage of the caseload management

Facilitated by Menard

Review of hypothetical case. Discussion of information that each agency would have in hypothetical case and how data-sharing does and does not occur. There is limited data-sharing between different law enforcement agencies, and 911 likely would not have that information. Public defender and DHS likely would not know immediately. Discussion of role of crisis triage center. Discussion of identification of mental health needs during booking and initial appearance. Challenges with connecting people to resources when they are released or bail out very quickly and unexpectedly. Interest in having a group of attorneys and judges who regularly deal with mental health cases available for these cases—not as a specialized docket/mental health court, but just as individuals who are knowledgeable in legal practices related to mental health needs.
