1. Discuss 2022 Funding for POS Contracts for Pretrial Services

Presented by Esqueda

The POS contract, which refers to funding peer support specialists and peer navigators, remains funded, but are waiting to contract with any organizations or individuals until the Pretrial Services Department and its director are finalized. This is a permanent budget item, so funding will continue to future years.

2. Update on Community Engagement and Community Conversations

Presented by Clark-Bernhardt

Dane County is receiving technical assistance from Advancing Pretrial Policy and Research (APPR). Part of this technical assistance includes holding community conversations, virtual townhalls, and dialogue with community members and organizations. There will be a strong focus on BIPOC voices in these conversations, and Dane County hopes to hold virtual meetings with affinity groups in November/December 2022 with larger virtual community conversations in January 2023.

Discussion regarding physical place to hold meetings. Virtual meetings have a lot of benefits, but it may also be worthwhile to coordinate events in areas heavily impacted by the criminal legal systems.

3. Update on the Hiring Process for the new PreTrial Services Director

Recruitment for candidates is complete, and eight candidates are being interviewed. The hiring committee is hoping to make a decision by the third week of November, with the person officially starting before the end of the year.
