1. State of Wisconsin Referenda on Cash Bail

The cash bail referendum recently passed in the April election. The cash bail provision allows for extra discretion. It is permissive in how it is interpreted by judges. It is currently challenging to determine what the impact will be because it is so recent. There will be an internal conversation among Dane County judges to determine its impact from a legal perspective; however, there is no specific plan at this time. There needs to be improved communication in the broader community about pretrial process, cash bail, and hindsight bias. Ongoing discussion will determine what is a serious crime. Discussion of preventative detention.
