## 1. WARRANT RESOURCE DAY--FOLLOW-UP DISCUSSION (DORL)

Catherine Dorl presented a summary of the data on warrant cases 1979-October 2019). Discussed ideas for a pilot warrant resolution/amnesty day.

Primary goal would be to have the warrant taken care of, get connected to a public defender, and get a court date to get cases back on track to resolve them.

Suggestion to set aside a wekeend day or night where people would be more likely to attend.

Would need commitments from DCSO, MPD, DA, Clerk of Courts.

#### Need to think about:

- Appropriate space--Does not have to be in a courtroom
- How and where to post names
- Other possible partners in the warrant resolution day. Perhaps the Lift Dane Initiative could be involved if authorized by the Clerk of Courts.

#### Next Steps:

Dorl will try to get demographic data (race, etc.) for the warrant cases per request from Stubbs to report at the next meeting.

## 2. COMMUNITY RESTORATIVE COURT UPDATE

Ron Chance gave the CRC update: 136 active cases as of 2/15/20. 4 staff with 29-43 cases per staff member. 66% (90) have repair harm agreements in place. 90% completion rate for repair harm agreements. Will be in new building and hiring additional staff person soon.

## 3. COMMUNITY JUSTICE CENTER

MacKinnon gave a summary review of the August 2019 brainstorming session of the CJC-RD, which answered three questions:

- What are the Strengths/Resources of Dane County Criminal Justice System?
- What are the Pressing Issues Around Dane County Criminal Justice System?
- What Resources are Needed for a Community Justice Center (that we do not have now)?

Subcommittee discussed next steps for scoping the RFP for a Needs Assessment for a Community Justice Center and directed staff to begin drafting the RFP for initial review by the co-chairs and then by the CJC-RD subcommittee and the CJC at their March meetings.
