#### D. Presentations

1. JAIL REENTRY INITIATIVES IN THE SHERIFF'S OFFICE  
(WAMPOLE-MACIEJESKI).

*Reentry is the process of releasing individuals back into their community. The Jail reentry team focuses on a number of portions of reentry planning, including employment, housing, education, mental health and substance use providers, and connections to community organizations. They use an assessment tool to determine what tools and services are most appropriate. The reentry team is open to learning about new reentry service providers and partners; it is not exclusive to existing services.*

*Discussion ensues. Interest in data availability, which will be available when a record management system is in place. This tool was made within the reentry planning team, and is not a SAMHSA official tool nor evidence-based. The pandemic posed additional challenges to providing services, due to lack of in-person contact. Reentry services are available based on release dates (including when they have advance notice about a P&P hold being released). The vast majority of people who are offered reentry services accept them. Discussion of some success stories. Housing is the biggest barrier at this point, because landlords do not accept people whose current address is the jail.*

**E. Reports to Committee**

1. COMMUNITY RESTORATIVE COURT UPDATE (CRC STAFF).

*The Community Restorative Court (CRC) continues its work and notes the partnership with law enforcement is a major strength. More officers from the Madison Police Department (MPD) are participating in circles. Victims are also attending more circles. The CRC is inputting data of current cases into its new case management system, and historic cases will be entered soon as well. The CRC presented to the police service academy of MPD, which MPD found beneficial. There is a strong focus on the language used by the CRC.*

## 2. COMMUNITY JUSTICE CENTER (CLARK-BERNHARDT).

*The CJC recently applied to a BJA grant with a \$600,000 award over 48-month grant period to fund the community justice initiative. If CJC receives the grant, it will require a fast timeline for pilot design, participants, and connections to CRC and social work wraparound services. Notification for the grant will be by October 2022. If Dane County does not receive grant, related work will continue on target populations and next steps.*
