- **Portfolio** of work spans the CJ system, from arrest and the pretrial period through the reentry process for returning citizens and parole
- Expertise in broad array of **research designs**, from randomized controlled trials to quasi-experimental methods to descriptive analyses

- 2) Identify the least burdensome pretrial supervision interventions necessary to maintain court appearance


Study Approach : Two Phases of Research

Phase 1: Process and Descriptive Analysis (all 8 sites)	 What are the practices and policies around pretrial release conditions and intervention strategies? How is pretrial supervision implemented? What are court appearance rates for defendants assigned to various release conditions and interventions?
Phase 2:	 Is a less restrictive pretrial supervision intervention
Impact	as effective as a more restrictive intervention
Studies	with respect to court appearance rates, new
(4 sites)	criminal charges, and other outcomes?

Data Elements Requested

Data provided by Dane County CJC and Circuit Court

- Arrest dates and charges
- Defendant demographics
- Risk assessment scores/information
- Pretrial release conditions and bail setting
- Hearings and hearing outcomes
- Court appearances and failures to appear
- Case outcomes/dispositions
- Pretrial services data: supervision levels, supervision start/end dates and end reasons, contact date and type, non-compliance, etc.

Phase 1: Deliverables

- Site-specific research report with results from Phase 1 data analysis (Summer 2021)
 - System and process map
 - Trends in court appearance rates over recent timeframe
 - Court appearance rates for:
 - o All cases
 - By release condition (supervision level and special intervention)
